Glen Blahuta moved with a second by Myles Marek to hire Kathleen Oldag as a teacher for Brazos Elementary for the 2012-2013 school year. The motion carried unanimously.

Superintendent Jack Ellis informed the board that Shawnya Minter had resigned her teaching position at Brazos High School.

Myles Marek moved with a second by Tamara Mager to hire Kelly Foitik as a Special Education teacher and LaShanda Moss-Hill as an English/Speech teacher for Brazos High School for the 2012-2013 school year. The motion carried unanimously.

Glen Blahuta moved with a second by Michael Scearce to hire Giselle Castorena as the Brazos Elementary Principal on a two year contract with the first year being probationary for the 2012-2013 and 2013-2014 school years. Board member, Myles Marek voted no. The motion carried 5 to 1.
