ARTICLE 1: Name

The name of this chapter shall be the Brazos Elementary Chapter of the National Elementary Honor Society (NEHS) of Brazos Elementary School.

ARTICLE 2: PURPOSE

The purpose of this chapter shall be to recognize students for their outstanding academic achievement and demonstrated personal responsibility, to provide meaningful service to the school and community, and to develop essential leadership skills within the students of Brazos Elementary School.

ARTICLE 3: POWERS

Section 1: This chapter operates under the direction of and in full compliance with the National Constitution of NEHS.

Section 2: The chapter adviser is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

Section 3: Final authority on all activities and decisions of the chapter resides with the school principal.

Section 4: Nondiscrimination. Our chapter of NEHS maintains policies and practices that are designed to prevent discrimination against any qualified candidate or member on the basis of race, color, religion, ancestry, national origin, gender, and disability. This policy of nondiscrimination applies to all activities and practices, including the chapter administration and the selection, discipline, and dismissal of members.

ARTICLE 4: MEMBERSHIP ELIGIBILITY AND SELECTION

Section 1: Membership in this chapter is an honor bestowed upon deserving students by the faculty and shall be based on the criteria of Scholarship and Responsibility.

Section 2: Membership in this chapter shall be known as active, honorary, and graduate. Active members become graduate members upon completion of their elementary school studies at this school. Graduate and honorary members have no voice or vote in chapter affairs. Membership in the National Elementary Honor Society does NOT automatically transfer membership into the National Junior Honor Society or National Honor Society.

Section 3:Eligibility

- a. Candidates eligible for selection to this chapter must be enrolled in grades 4 or 5.
- b. To be eligible for selection to membership in this chapter, the candidate must have been enrolled for a period equivalent to one semester at Brazos Elementary School. This can be waived if the Faculty Council approves.
- c. Candidates eligible for election to the chapter shall have a minimum of cumulative grade point average of A 90.
- d. To be eligible for selection for membership in this chapter, the candidate must have been without excessive unexcused absences or tardiness.
- e. Pass all STAAR tests that were given for your grade level.
- f. No ISS assignments prior to nomination.
- g. No DAEP or suspensions prior to nomination.
- h. Upon meeting the grade level, enrollment, and GPA standards, candidates shall then be considered based on their demonstrated personal responsibility.

Section 4:The selection of members to this chapter shall be by a majority vote of the Faculty Council which consists of faculty members (consisting of the NEHS adviser, counselor, and students teachers) appointed by the principal. The chapter adviser is a nonvoting member of the Faculty Council who facilitates all meetings of the council.

Section 5:Prior to the final selection, the following shall occur:

- a. Students' academic records shall be reviewed to determine scholastic eligibility.
- b. Students who are eligible scholastically shall be notified and asked to complete and submit the Candidate's Form for further consideration.
- c. The faculty shall be requested to evaluate candidates determined to be scholastically eligible using the official evaluation form provided by the chapter adviser.
- d. The Faculty Council shall review the Candidates Forms, faculty evaluations, and other relevant information to determine those who fully meet the selection criteria for membership.

Section 6:The selection of active members shall be held once a year during the second semester.

Section 7: Candidates become members when inducted at a special ceremony.

Section 8: Transfer membership: Membership can be transferred from one chapter of NEHS to another.

- a.An active member of the National Elementary Honor Society who transfers from the school with an active chapter of NEHS will be given an official letter indicating the status of his/her membership.
- b.An active member or the National Elementary Honor Society who transfers to this school will be automatically accepted for membership in this chapter. The Faculty Council shall grant to the transferring member at least one semester to attain the membership requirements and, thereafter, this member must maintain those requirements for this chapter in order to retain his/her membership.

ARTICLE 5: OBLIGATIONS OF MEMBERS

Section 1: Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall be entitled to wear the emblem adopted by the National Elementary Honor Society.

Section 2: Currently there are no dues for this chapter, however should the organization need dues or collection of monies in order to sustain its functions, a due may be necessitated and cannot be more than \$20.00 per school year. The dues would be due to the chapter treasurer within 30 days of induction.

Section 3: Any member who withdraws, resigns, or is dismissed from the chapter shall return the emblem to the chapter.

ARTICLE 6: OFFICERS

Section 1: The officers of the chapter shall be president, vice president, secretary, and treasurer.

Section 2: Student officers shall be elected in a timely fashion on a date designated by the chapter adviser each school year. All active members are eligible to run for a position as an officer.

Section 3: A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

Section 4: It shall be the duty of the president to preside at the meetings for this chapter.

Section 5: The vice president shall preside in the absence of the president and shall also keep record of members' contributions in the areas of leadership and service.

Section 6: The secretary shall keep the minutes of meetings and be responsible for all official correspondence of the chapter.

Section 7: The treasurer shall keep the record of expenses, dues, and all other financial transactions of the chapter.

Section 8: Officers shall serve a term of one year.

Section 9: Officers and the faculty adviser shall collectively be known as the chapter's Executive Committee. The Executive Committee shall have general charge of the meetings and the business of the chapter, but any action by the Executive Committee is subject to the review of the chapter members. The principal will have the final decision if needed.

ARTICLE 7: MEETINGS

Section 1: Meetings of this chapter shall be held one time per month. Additional meetings may take place as necessary to complete projects.

Section 2: This chapter shall strive to conduct its meetings according to Robert's Rules of Order.

ARTICLE 8:ACTIVITIES

Section 1:The chapter shall determine one or more service projects for each school year. A minimum total of four official activities will be conducted each year.

Section 2:All members of the chapter shall regularly participate in these projects.

Section 3:These projects shall have the following characteristics: fulfill a need within the school or community, have the support of the administration and the faculty, be appropriate and educationally defensible, and be undertaken in a well-planned and organized manner.

Section 4:The chapter shall publicize and promote its projects in a positive manner.

ARTICLE 9: DISCIPLINE OF MEMBERS

Section 1:Any member who falls below the standards of scholarship and responsibility may be considered for disciplinary actions by the Brazos Elementary National Honor Society chapter of the National Elementary Honor Society. A member of the National Elementary Honor Society is expected to maintain his/her academic standing, be responsible in all aspects, and take an active role in service and leadership to his/her school and community.

Section 2:If a member's cumulative grade point average falls below the standard in effect when he/she was selected 90%, he/she will be given a written warning and a reasonable time period for improvement. If the cumulative grade point average remains below standard at the end of the warning period the student will be subject to further disciplinary action by the Faculty Council that can include consideration of dismissal from the chapter.

Section 3:Violations of the law or school code of conduct (such as profanity, unexcused absences, excessive tardiness, stealing, destruction of property, cheating, etc) can result in immediate consideration of the dismissal of a member.

Section 4:Offenders of the school code of conduct will receive a written warning. A conference may be requested by either party (Faculty Council/parent). If the member is involved in additional violations of the school conduct code, the member may be considered for dismissal.

Section 5: In all cases of pending dismissal:

a.The member will receive written notification from the adviser indicating the reason for consideration of dismissal.

b.The member will be given the opportunity to respond to the charge(s) against him/her at a hearing before the Faculty Council. This will take place prior to any vote on dismissal (in accordance with due process identified in the National Constitution). The member has the opportunity to present his/her case either in person or through a written statement presented instead of the face-to-face hearing. Following the hearing, the Faculty Council will vote to determine the appropriate disciplinary action. A majority of the Faculty Council is needed to dismiss any member.

c.The results of the Faculty Council vote will be presented to the provincial for review, and then stated in a letter sent to the student and parents. Dismissed members must surrender any membership emblems to the adviser.

d.The Faculty Council's decision may be appealed to the building principal and afterwards accruing to the provisions of the school district discipline policies.

e.Members who reigns or are dismissed can be reconsidered for membership upon written request to the chapter advisor.

Section 6:In lieu of dismissal, the Faculty Council may impose other appropriate disciplinary measures upon a member.

ARTICLE 10: RATIFICATION, REVIEW, AND AMENDMENTS

Section 1:Ratification. These bylaws will be approved upon receiving a two-thirds affirmative vote of all active members of the chapter, a majority affirmative vote of the Faculty Council, and approval by the administration.

Section 2:Review. These bylaws shall be reviewed and, if necessary, revised within five years from the date of approval noted on this document.

Section 3:Amendments. These bylaws may be amended by a $\frac{2}{3}$ vote of the chapter, provided notice of the proposed amendment has been given to members at least one month prior to the vote. The exceptions are any provisions regarding selection of members and chapter disciplinary guidelines, which are developed by the Faculty Council with the approval of the principal.

Amendments for 2024-2025 school year-

Amendment to section 3: Eligibility

c.Candidates eligible for election to the chapter shall have a minimum cumulative grade point average of 90% in subject.

d.To be eligible for selection for membership in this chapter, the candidate must have been without excessive unexcused absences or tardiness. Students can have no more than 3 tardies per school year. Students can have no more than 3 unexcused absences per school year.

Section 7:Candidates become members when inducted at a special ceremony. Inductions will take place once a year in the fall semester, after checking grades, STAAR scores, and behavior.

Amendment to section 6:

The selection of members will occur during the summer or fall semester after all criteria are met.

Article 5:Obligations of members

Section 4:Members will be required to participate in 1 UIL event per year.

Article 6: Officers

Section 2:Student officers shall be elected in a timely fashion on a date designated by the chapter adviser each school year. All active members are eligible to run for a position as an officer except if on suspension or probation.

Article 8:Activities

Section 2: All members of the chapter shall regularly participate in these projects. Members must complete a minimum of 1 service hour, not including the parades.

Article 9:Discipline of members

Section 2: Members must maintain at least a 85% cumulative grade point average after induction, and have no grade lower than an 80 on the report card. If these standards are not met students will be placed on suspension until grades are brought up to the standard, or students may be removed from the organization. If students have below a 80% cumulative grade point average they will be removed from the organization. Members must also have no more than 3 unexcused absences per school year, or they may be considered for removal from the organization.

Section 3:-Violations of the law or school code of conduct (such as profanity, unexcused absences, excessive tardiness, stealing, destruction of property, cheating, etc) can result in immediate consideration of the dismissal of a member. If a member has a discipline referral, the principal, counselor, and advisors will discuss suspension based on the offense. If a student has ISS more than once during their membership they will be removed from the organization.
